Why you should purchase Travel Protection:

Purchase Within 14 Days of Your Initial Trip Deposit for Pre-Existing Condition Waiver: The Pre-Existing Condition exclusion will be waived if the protection plan is purchased within 14 days of the initial Trip deposit. You purchase this policy for the full non-refundable cost of Your Trip. You are not disabled from travel at the time You pay the plan cost and this is the first and only booking for this same destination and dates of travel.

Cancellation Protection: You may cancel the Protection Plan by giving us written notice within either fourteen (14) days from the date of issuance of Your protection plan, or Your Scheduled Departure Date whichever occurs first, provided You have not submitted a claim. If You do this, we will refund Your plan cost in full (less the \$6.00 administration fee). If past fourteen days, your plan cost is nonrefundable.
